	 The Early Years Niagara Research Group's Parent Knowledge Study will provide the project with an understanding of what components of parenting parents are well-versed in and where knowledge gaps exist. Parent Knowledge Survey questions are based on the 5 Early Development Index (EDI) domains. Phase Two of the Parent Knowledge Study will include a survey for parents of children aged 7-12. Phase Two will not be linked to the Innovation Fund project and therefore not follow the ministry's timelines. The Parent Knowledge Survey will be launched in January 2014. K. Catherwood is interested in completing a validation process for the Parent Knowledge Survey that includes parent focus groups. Research on what websites parents most frequently visit and where they get parenting information will be completed. If BSCFSSC members have recommendations they will connect with S. Noel and K. Catherwood. The Innovation Fund project's timelines have shifted from what was previously reflected on the work plan however all components of the project will meet ministry timeline requirements. Out of interest, the committee will ask J. Van Lankveld to provide BSCFSSC with an update on the Speech Services Niagara's 	K. Catherwood will work with K. Wilcox to determine the best way to market the survey in rural areas of Niagara.
Other Business	 Innovation Fund project. Plan for January's Agenda At the January BSCFSSC meeting committee members will discuss key aspects of building a Best Start Child and Family Centre (BSCFCs). This will provide a foundation for the Ministry of Education's announcement on BSCFCs in September 2014. Reflective Practice Training 82 Individuals are currently registered for Engaging our Hearts and Minds in Reflective Practice. Of those registered, 56 are staff from Ontario Early Years Centres and other Family Resource Programs. The remaining 26 individuals registered are from licensed child care facilities. Niagara Region Children's Services is subsidizing one space for each licensed child care centre that has pre-school aged children. Assistant Deputy Minister of Education Jim Grieve will be speak on the first day of the two day training. Hub Operators Committee It would be beneficial for the Hub Operators Committee to do a presentation at a Niagara Child Care Sector meeting outlining the collaborative work they are doing. A community meeting in winter 2014 may be an opportunity to do this. Children are Safe – Seeds of Empathy Proposal The Children are Safe Pillar Committee is currently developing a proposal that will be submitted to Mary Gordon (founder, Roots of Empathy) that would see a pilot Seeds of Empathy program at a drop in based Family Resource Program. The pilot program would be consistent with as many of the Seeds of Empathy requirements as possible. If an Ontario Early Years Centre, Parent and Family Literacy Centre or other Family Resource Programs are interested in being considered as the host of the pilot Seeds of Empathy program they will connect with S. Toth. This information will be passed on the Hub Operators Committee by N. Lisi. The proposal will be submitted to M. Gordon in September 2014. 	K. Catherwood, K. Wilcox, J. Smith and D.
